



Ikhodi Yokuziphatha kwalabo esisebenzisana nabo kwi Sappi Group

Ngokuhambisana nemigomo yokusebenza ngokubambisana ka One Sappi – lapho sizinikele khona ukubambisana nokusebenzisana nabanye ababambe iqhaza ebhizinisini lethu – sihlose ukuba inhlangano ethembekile futhi enekusasa eliqhakazile embonini yezingodo. Sithatha labo esisebenzisana nabo njengophathina ababalulekile futhi abadlala indima emqoka eyenza sikwazi ukufeza lezhinhoso esinazo.

Ilesizathu esenza silindele ukuthi zonke izinkampani esisebenzisana nazo zisijoyine ekuzibophezeleni kwethu ekunakekeleni umnotho, inhlalakahle yabantu nokunakekelwa kwemvelo ngenhoso yokwakha indawo eqotho yokwenza ibhizinisi ngokuthembeka nangesibindi; lapho esithatha khona izinqumo ezihlakaniphile ngokushesha.

Ububanzi bokuqinisekisa ukuthi kuyalandelwa lokhu

Lekhodi yokuziphatha (ikhodi) yakhelwe ukuqinisekisa ukuthi izimiso zokuziphatha zakwa-Sappi zicacile futhi zisekwa yizo zonke izinkampani esisebenzisana nazo, izinhlangano ezisebenzisana nazo kanye nabanye esibambisene nabo ebhizinisini. Ngokufanele, esisebenzisana nabo kulindeleke ukuthi:

- Bahloniphe amalungelo abantu futhi bagcine izimiso ezishicilelwe kumqulu we-United Nations ngamalungelo abantu.
- Ukuphatha bonke abasebenzi babo ngenhlonipho; ukugcina imigomo nemithetho eyanele yokuvimbela noma iluphi uhlobo lokuhlukunyezwa; futhi ikhiphe izinhlaka zokuveza nokubika izikhala zo ezihllobene namalungelo abantu.

Ukusebenza kwezingane nabasebenzi abasebancane

- Gwema ukusebenzia izingane ngokungaqashi abantu abaneminyaka engaphansi kweyi-15, ngaphandle uma umthetho-sisekelo wezwe ukhipha umkhawulo weminyaka ongaphezulu ovumelekile.
- Ukuvikelwa kwabasebenzi abaneminyaka engaphansi kweyi-18 kwimisebenzi yanoma iluphi uhlobo olungathunaza umzimba, umqondo noma ukukhula ngokwemizwa.

Ukukhetha umsebenzi ngokukhuleka

- Gwema ukusebenzia abantu ngokubaphoqa, ukubenza izigqila nokuphoqa iziboshwa ukuthi zisebenze.

Amahhora okusebenza

- Hlela izikhathi zokusebenza nezinsuku zekhefu zonyaka ngokulandela umthetho nemigomo yezwe osebenzela kulona.

Imiholo

- Khokhela abasebenzi, okungenani umholo nesinxephezelo sokusebenza isikhathi eseqile esihambisana nomthetho nokwenziwa embonini.

Inkululeko yokujoyina izinhlangano zabasebenzi

- Khumbula futhi uhloniphe ilungelo labasebenzi lokuba nenkululeko yokujoyina izinhlangano zabasebenzi ngokulandela imigomo yomthetho-sisekelo wezwe.

Ukucwasa

- Hlonipha ukwehluka kwabantu emsebenzi, unlikeze abantu amathuba alinganayo futhi uqinisekise ukuthi indawo yokusebenza ayinakho ukucwasana.

Ezokuphepha nezempi

Abantu banelungelo lokuphila nokusebenza ngokuphepha, nokuthi bathole isiqiniseko sokuthi indlela yokwenza umkhiqizo angeke idale umonakalo ezimpilweni zabo nasekuphepheni kwabo futhi angeke bathenge imikhiqizo ezokwenza umonakalo ezimpilweni zabo.

Ngokubheka lokhu, izinkampani esisebenzisana nazo kulindeleke ukuthi:

- Zibeke kuqala futhi zakhe indawo yokusebenza ephephile futhi evikela izimpilo zabasebenzi ngokuhlola bonke ubungozi; Ziqeqeshe abasebenzi ngezokuphephha nezempiro futhi zakhe izinhlelo nemigomo yokubhekana nezimo eziphuthumayo. Lokhu kubala ukubikwa kwezimo eziphuthumayo, ukwaziswa kwabasebenzi, ukuqeleshwa kwabasebenzi, izimpahla zosizo lokuqala, imishini efanele yokutholwa nokucishwa kwemililo nezindawo ezanele zokuphuma uma kunezimo eziphuthumayo.
- Ukukhipha imikhqizo nomsebenzi okungenani ohambisana nemithetho yekhwalithi, ezempilo nezokuphephha ehambisana nomthetho wezwe.
- Ukusebenzisa uhlelo lokongamela ezokuphepha, ezempilo, imvelo nekhwalithi.

Amakhemikhali

- Ukwakhiwa kwendlela yokuthenga, ukuthutha, ukugcina, ukuphatha nokusebenzisa amakhemikhali ngendlela evikela imvelo nezimpilo nokuphephha kwabasebenzi ngaso sonke isikhathi.
- Ukubhala, ukugcina kanye nokushintsha uhlwano wonke amakhemikhali assetshenziselwa ukwenza umkhiqizo futhi kugcinwe amarekhodi aphahelene namakhemikhali assetshenziswayo.

Imvelo

Ukukhiqiza okuningi usebenzisa okuncane kubalulekile ekwakheni izimakethe ezizozinza ezihambisana nokugcina umhlabo wethu uphephile, futhi ingcebo yemvelo ivikelekile ukuze sidlale indima ekuthuthukiseni umnotho nenhlalakahle yabantu. U-Sappi uhlose ukuvikela umhlabo ngokunakekela nokuvikela imvelo, ukuqapha isimo sezulu nezinhlobonhlobo zezinto eziphilayo.

Ngokubheka lokhu, izinkampani esisebenzisana nazo kulindeleke ukuthi:

- Zithobele umthetho-sisekelo wezemvelo othinta imisebenzi yabo.
- Ziqinisekise ukuthi zithola futhi zigcina imihlahlandlela yokubika konke ukubhaliswa nama- permit ezemvelo ukuze zihambisane nemithetho.
- Ukubheka umthelela ezinawo kwimvelo ikakhulukazi kwizinto eziphilayo, ukungcolisa imvelo futhi zilungise lapho kunomonakalo khona.
- Qeqesha abasebenzi ngobungozi obuhlobene nezemvelo ngokuhlola okuhambisana nezinhlelo zokunakekela imvelo.
- Sebenzisana no-Sappi ukuze uqhubeke uthuthukise izinga lakho lokuvikela imvelo ngoku:
 - Nciphisia intuthu yegesi nokusebenzisa ugesi
 - Ukuthuthukisa ikhwalithi yamanzi nokunciphisa udoti
 - Ukuthola izindlela ezingcono kunokusebenzisa amakhemikhali nempahla enobungozi.
- Yakha izinhlelo zokuthenga, ukuthutha, ukugcina kanye nokubamba udoti ngendlela ezovikela imvelo futhi iqinisekise ukuphephha kwabasebenzi.
- Ukugcina irejista yezinhlolo zikadoti ukuze kuhlukaniseke udoti oyingozi nongasiyona ingozi.
- Uma kunezicelo, khapha imininingwane yemvelaphi yensiza-kusebenza, okungaba izihlahla nokunye ukuze uSappi uhlole ubungozi obukhona kulezonsiza-kusebenza nalapho ezivela khona.

Ukwehluka kwabantu namathuba alinganayo

Sikholelwa ukuthi ukwehluka kwabantu kuvula indlela yokuthola imicabango emisha futhi kuyasiza ekuletheni amasu amasha. Ingakho sikubona kubalulekile ukuba nabantu abahlukahlukene futhi siyayibungaza indima abayidlala ebhizinisini lethu, okulenza lihambe phambili futhi lihambisane nezikhathi ezishintshayo. Siyakulwela ukwakha indawo lapho umsebenzi ngamunye ethola khona inhlonipho ngaphandle kokubhekwa kweminyaka yakhe, ibala, inkolo, ukukhubazeka, ubulili kanye nokunye. Ngokubheka lokhu, zonke izinkampani esisebenzisana nazo kulindeleke ukuthi ziqhakambise ukwehluka kwabantu futhi zikhipe amathuba alinganayo.

I-Broad-based black economic empowerment (BBBEE)

Siyazi ukuthi ushintsho eNingizimu Afrika akusiyo nje into eyenziwa ngempoqo ngoba ibalulekile, kodwa uhlelo lokukhulisa umnotho wezwe olwenziwa ngokuhambisana nokubuyisela abamnyama ezinhlwani zokuthuthukisa umnotho. Okwethu okupathelene ne-BBBEE, ukwenza umehluko oqotho.

Silindele izinkampani esisebenzisana nazo ukuthi zibe ingxene yeyalokhu futhi:

- Zizibophezele, uma kuyinkampani yase-Ningizimu Afrika, kwizimiso ze-BBBEE njengoba zibekiwe kwikhodi yokusebenza kahle ye-Department of Trade and Industries ethinta Ukuthuthukiswa Kwabamnyama Kwezomnotho. Amabhizinisi angaphansi kwaloluhlelo kuzodingeka anikeze uSappi ikhadi lamaphuzu, ngokulandela umthetho.

Ukuthobela lekhodi

Uma sixhumana nalabo esisebenzisana nabo, sizobheka ubukhulu nokuvuthwa kwenkampani. Ukukhombisa ukuthi iyalandelwa imigomo yale-khodi, izinkampani kungadingeka ukuthi zikhipe amadokumenti noma zivumele uSappi okanye abamele wona ukuthi benze ucwaningo lwamabhuku ezindaweni zabo zokusebenza.
